How can older people be better supported to enjoy autonomous lives? How can we guarantee that people remain able to enjoy their right to self-determination as they age? What services and support are necessary to allow older people with care needs to live in dignity and remain independent and autonomous to the greatest possible extent?

AGE Annual Conference 2018 will explore how older people can enjoy their freedom to make choices, manage their own lives and live as autonomously and independent as possible. Gathering older people and their organisations together with other civil society representatives, researchers and policy makers, the event will discuss how, concretely, policies and legislation could better contribute to allowing older people to enjoy their right to autonomy and independence. The conference will also explore how care and assistance services can support older people to live in dignity and as autonomously as possible, including those who have a life-threatening condition and require palliative care.

The outcomes of the conference will feed AGE contribution to the ongoing discussions on the enjoyment of human rights by older persons at United Nations' Open-Ended Working Group on ageing, as well as in current and future European Union initiatives such as the implementation of the European Pillar of Social Rights.

### Breakout session A

#### **Older people's rights to autonomy and independence: legal capacity and participation to civic, social, economic and cultural life (with interpretation)**

This session will elaborate on how policymaking can contribute to ensuring the rights to autonomy and independence of older people in all aspects of their lives – in exercising their legal rights, and in participating to civil, political, social, economic and cultural life. It will discuss concrete examples of violation of these rights, and also how to guarantee older people in such situations can seek redress.

### Breakout session B

#### **Quality long-term and palliative care for ageing well and enjoying independent living (no translation)**

also in cases where such needs are high. The session will finally explore what interventions and policies could enhance the dignity and wellbeing of older persons with a life threatening condition through the access to good quality palliative care.
